### IMPORTANT COMMUNICATION No. 1/2023

In receipt of several representations from film and trade associations, particularly from the South, to allow certification of Hindi dubbed versions in the respective region where the original version of the film is certified, industry feedback and comments of the Regional Officers of CBFC were sought.

Based on the feedback received, the Chairman CBFC has decided to withdraw the Important Communication issued on 19-4-2017 (copy enclosed) and allow the application and certification of Hindi dubbed films in the region where the original version of the film is certified. This decision will be initially effective for the next 6 months from 20-10-2023, on a trial basis, and the applicants may hereinafter submit their applications for Hindi dubbed films at the respective Regional Offices of CBFC.

During the trial period of six months, the impact on the workload and language expertise at various regional offices of CBFC will be assessed and monitored thoroughly. If it is observed that the decision does not hamper the smooth functioning of CBFC Regional Offices, a final decision will be taken in this regard.


